

The *Book of Sorrow 2002* was published by the Kazakhstan Historical and Education Society. It includes lists of persons shot for political reasons, accusations on the territory of the North-Kazakhstan region of the Republic of Kazakhstan in 1920-1950. The publication was carried out with the support of the Akimat of the North Kazakhstan region of the Republic of Kazakhstan. The list below is just an excerpt of the book and contains **only those listed as “German”**. A digital copy of the book was provided to BSGR by Eugen Beck. BSGR only translated the “German” individuals in the book using Google translate.
